[Local 695's grievance against Local 600 regarding Video Assist being performed by camerapersons and President Loeb's letter of response were read to the members.] President Loeb has appointed International Representative Julia Neville to conduct an investigation into this matter.

We are moving forward with action against Disney for sub-contracting work on video walls for the production of The Mandalorian.

MPI has just announced another extension of benefits for the period ending October 24 and will once again offer free COBRA coverage to any previously covered member who has at least 1 hour of worked or banked hours.

Laurence Abrams reported on the Sound & Video Opportunity Program: The SVOP has been moving forward with our current group of Y-16A Trainees, having put them through 2 days of pre-training with Local 695 conducted by Jamie Gamble, Ben Greaves, Eva Rismanforoush, Johannes Skoda and Laurence Abrams. At this time we have 5 trainees working on shows and 3 more scheduled to begin within the next 2 weeks.
